

4. Appointment will be of temporary and contractual nature for a maximum period of the duration of the scheme.

The appointment of the above post will be initially for three months and may be continued for one year and may be extended further with mutual consent and based upon the satisfactory performance of the incumbent. The institution, however reserves the right of termination of services of the appointee forth with or before the expiry of stipulated period without assigning any reason.
6. In the circumstances of more number of applications scrutiny will be done and interview will be taken as per merit.
7. No TA/DA will be admissible for the attending interview.
8. Other service conditions will be as per the existing rules for contractual staff of the Department.
9. The personnel will have no claim for regular/permanent appointment under the Research Councils /Ministry of AYUSH or the grantee institution on completion of the period of appointment.
